### Board News – by Jane Yates

The LCBA board has been discussing whether to expand LCBA membership. We are considering whether to open membership to all OSB members and other non-attorneys, such as legal assistants, vendors, etc. (the Multnomah Bar Association allows these individuals to become members). Currently, membership is open to members of the Oregon State Bar who reside or maintain offices in Lane County and University of Oregon, School of Law faculty. Upon Board approval, holders of juris doctor degrees from ABA accredited institutions who reside or maintain offices in Lane County, Oregon may also become members. In addition, law students enrolled in an ABA accredited law school are eligible to join the LCBA (but cannot vote or become a member of the board). The Lane County Bar Association represents a vital infrastructure on which the legal community can build a number of functions that benefit local lawyers and the public. For example, the LCBA sponsors committees (e.g., Debtor/Creditor, Employment Law) that provide support, networking, and continuing education for lawyers practicing in various disciplines. For new lawyers, LCBA produces mentoring and programming opportunities that help integrate them into the legal community. When the governor seeks input on potential judges, the LCBA steps in with its Judicial Applicant Review Committee. And an important dimension of LCBA's work is fostering professionalism and civility in a world in which the obligations of advocacy can fray interpersonal relationships. Without the scaffolding of a local bar association, Lane County's lawyers – and the public they serve – would be the poorer.

### LCBA Website - by Tom Moseman



The members-only section of the new LCBA website is now fully up and functioning, and all active LCBA members should now be able to login on the bottom left of the members-only page here: <https://lanecountybar.org/index.php/members-area>.

Login requires a username and password that many members received in an email about being added to the system months ago and that other members only received recently. Username is typically a member's first name initial, followed by a period, followed by the member's last name; for example: John Smith's username would be J.Smith. Passwords were randomly assigned (see the email about being added to the system) and the website will ask each member to create his or her own password on the member's initial login.

Members can also retrieve usernames and passwords on the members-only page provided above, by clicking on the "Forgot your username?" and "Forgot your password?" links, respectively. Such retrieval requires members to enter in the email address they provided when they registered and paid their LCBA dues. If you are an active member and you cannot retrieve your username and password using the email you believe you provided, please contact us at: [administrator1@lanecountybar.org](mailto:administrator1@lanecountybar.org).

Once logged in, members should note the navigation pane on the right of the member-only page that allows access to restricted, members-only information. Of particular note, members can create their own listing in the "Members' Directory" by clicking that link and then clicking "Add Entry" at the top of the directory page.

Newsletters and archives will soon only be available through this restricted members-only area and the LCBA is also looking to add select resources, such as CLE materials, to this area as well.

Lane County Circuit Court will go live on the Oregon Judicial Department's ePay website on April 28, 2012. OJD ePay will allow individuals to pay online for many types of court cases including most traffic citations and many criminal and civil cases. This will provide ease of payment with a credit or debit card and will be convenient for out-of-state or out-of-county traffic ticket payments. I am told that it is the hope of OJD to have new forms available by the Fall of 2012. ### Campaign for Equal Justice

This is our final report for the 2011 Campaign for Equal Justice. We are pleased to announce that the Lane County Bar Association is the first recipient of the Justice Cup awarded for our fund raising efforts for the 2011 Campaign! The award is given to the region that has the highest percentage of contributors to the Campaign for Equal Justice. As of February 21, 2012, we had 310 contributors (representing 28.5% of our members) who gave a total of \$86,153 for CEJ. Multnomah County had the next highest percentage with 26%. Lane County's final results were an improvement over last year's efforts.

Even though only a little more than a quarter of our members contributed to this Campaign, I am pleased with our efforts, given the difficult economy, and the fact that there are a number of other well-deserving programs that compete for the available charitable dollars.
